- Carl in Facilities – why do we not have uniform policies across all units? Specifically for bereavement. UNT Denton specifically says “spouse, parents immediate family. All other units say Aunts, uncles, nieces nephews, in-laws.” Revised three years ago, Denton looks to have been chopped up bad.
