- I. Call to Order (5 minutes): 3:02 PM
- II. Speakers/Presentations (15 minutes)
 - i. UNT Safety and Incident Management Advisory Group.
 - a) Brandi Renton, Cynthia Hermann, David Reynolds and Katy McDaniel are part of the group
 - b) There has been an increase in the number of COVID cases.
 - c) Contact Tracing COVID hotline has worked really well. We need everyone to encourage reporting.
 - 1. Contact tracing starts with case investigation and 90% of information come from here.
 - 2. Contact tracing team consists of 10-12 full-time staff members.
 - 3. Response time is quick and most case investigations are done within 24 hours.
 - **d)** COVID Dashboard has been expanded based on feedback from students, staff and faculty.
 - 1. The numbers include all self-reports and campus testing as well.
 - 2. On the dashboard, Direct Campus Impact are community members that have been on campus during their infections period, while Indirect Campus Impact are those that have not been on campus.
 - e) Denton County Public Health continues to conduct testing at UNT locations.
 - 1. Use the UNT code when you signup and register for the test.
 - 2. Tests are free and not restricted to the UNT community only.
 - **f)** Need to keep up the distancing, hand washing and mask wearing.
 - g) Outside of work there is not much the university can do to enforce compliance to COVID safety measures.
 - ii. Senator Tow, GSC
 - a) Need to amend ODA attendance and late grade policies to accommodate students with certain conditions that have problems with attending class and completing assignments.
 - b) Recommending better training on ODA accommodations for faculty and staff of UNT.

iii. Valerie Parker, UNT HR

- a) Staff Awards nominations have closed. Two hundred and sixty nominations were received.
- **b)** Selection process is now underway. Recipients will be announced and awards will be presented in the spring.
- c) Mid-year performance reviews are due by November 17, 2020.
- **d)** The People Admin Module will open up on November 18, 2020 for managers to be able to enter their goals for the annual performance review period.
 - 1. Communication on training will be coming out soon.
- e) The university has resources specifically designed to support pandemic stress through the Employee Assistance Program (EAP).
- f) Constituents Concerns submitted will take a little more research. Feedback will be communicated through the Executive Committee.

 - a) There are currently ERGs through Diversity & Inclusion like UNeTe (for Hispanic/Latinx employee), Black Professional Network, and Neurodiversity Professional Network but not one specifically for people with disabilities.
 - **b**) The Chair noted that the Staff Senate Policy and Benefits committee can bring more attention to this issue.
