- a) Nadia Guevara, Director UNT Youth Protection Program (Administrative Services)
 - i) The Youth Protection Program (YPP) oversees the Youth Protection policy implementation and compliance across all colleges and divisions of the University.
 - ii) It is responsible for providing a safe and healthy environment for the protection of minors participating in programs on and off campus.
 - iii) Program scope also covers groups and individuals working with non-student minors under the age of 18, both on and off campus.
 - iv) Faculty, staff and students must comply with policy
 - v) Every youth program, event, or activity in UNT has an obligation to ensure the safety of minors.
 - vi) Groups and individuals planning activities for non-student minors under the age of 18 are required to work through YPP and provide notification of these events in advance.
